Prescription Drug Plan Price Comparison

As healthcare costs continue to rise, every penny saved can make a difference. Did you know that Benefit Coordinators and members have access to the Price Comparison Tools available with Express Scripts to assist in determining out of pocket expenses on prescriptions drugs? Click the link and do your homework before you head to the pharmacy to determine the best plans for you and your family. [Express Script Price Comparison Tool](#)

SaveOnSP

Express Scripts provides members with access to a copay assistance program, administered by SaveOnSP, designed to help offset costs for select specialty medications. Participation in this program is mandatory and participants are enrolled automatically.

SaveOn reaches out when it identifies eligible members taking the drugs that are included. A list of drugs eligible under the SaveOnSP programs can be found [here](#).
